

runs in the family. The identical twins and Covington FFA members carved a unique piece of Tennessee FFA history as the first set of twins to both hold the title of Tennessee FFA State Star Farmer and in consecutive years. Mitch was named the 2022 Tennessee State Star Farmer at the 94th Annual State Convention, and Mike followed up with the title in 2023 at the 95th Annual State Convention. From brothers to business partners, these young men have each dedicated a lifetime to the success and growth of the family farm.

Eagerly following in the footsteps of their father, mother, and grandfather, Mitch and Mike Hopkins have always had a love of agriculture. Mitch and Mike, along with their older brother Nathan, are the third generation of Hopkinses to grow



cotton, wheat, and soybeans over several counties in West Tennessee under Hopkins and Hopkins Farms.

From a very young age, they tagged along with their father, Glenn, to the farm and the shop. After years of observing and studying the workings of the farm, at the age of 12 they were tasked with running the grain cart tractor for the combines in the field. With each crop planted and harvested, their experience, knowledge, and leadership skills grew exponentially.



Mitch and Mike are now involved in every aspect of the family farm and have started independent

soybean operations. During the crop season, you can find them performing manual labor and maintenance or driving and operating every piece of equipment on the farm including planters, sprayers, combines, cotton pickers, and large trucks. In 2019, the brothers, equipped with years of agricultural insight, each took out a Farm Service Agency Youth Loan for seed,

chemicals, and fertilizer to independently plant their own 20 acres of soybeans. In just three years, they each grew to a 150-acre operation, but not without a few doubts along the way. Utilizing the same help as their family farm proved to be a challenge in finding their place as managers and leaders.

Mitch explained, "The single greatest challenge I have faced within my Supervised Agricultural Experience is becoming a leader. I have been so used to being an employee under my dad, grandfather, and older brother. They were always the ones to make executive decisions over me. However, as time went on, situations came up where they were not around and a decision had to be made. My dad would tell us that we will need to begin making decisions when he is not around. From his and our other

employees' confidence in our ability to make decisions, we were able to overcome this challenge and become the leaders this farm needed. We are now comfortable making small decisions such as moving to certain fields and larger decisions such as buying and replacing certain parts and specific chemical application rates."

Discipline and responsibility have been the foundation of their expansion, from environmental stewardship to financial management. They take many steps to ensure that their farm is sustainable in terms of continuity, conservation, and innovation.

"Taking loans out, paying rent, and purchasing chemicals and seed have taught us money management practices. I cannot just spend money however I want because at the end of the day, there are people that need to be paid," Mike noted.

The brothers attend programs put on by different seed companies and grain associations



to learn about imports, exports, price fluctuation, and supply and demand. They also take care of the soil in several different ways. No-till is

an important tool they use to prevent erosion on their farm. Partnering with the Natural Resources Conservation Service (NRCS) to build terraces and catch basins has proven effective to prevent soil erosion and ensure a good soil profile for the future. Safety is an integral part of farming, from small- to large-scale operations, and is evident at the Hopkins' farm. In addition to using proper Personal Protective Equipment, they remain cautious of their surroundings when running farm equipment. "Mitch and Mike are very safety conscious, responsible, and accountable. A person can't be put on farm machines without these qualities," said their father, Glenn Hopkins.

Joining FFA has allowed them to use their farming operation as a robust Supervised Agricultural Experience while developing premier leadership skills along the way.

"Without investing this much time, money, and effort into the farm, as well as our FFA chapter, I know that we would not be where we are today," said Mike. "This SAE has given us the will to work hard. We have worked in the blazing sun and in the freezing cold. We harvested into

December and on holidays this year because of rain. It can be very tough, but the rewards are worth it. We find a lot of joy in our work, in school, and in FFA." He continued, "We have become much more comfortable being in a group since the beginning of our high school careers because of FFA. We love having advisors who coach us in so many different ways. Mr. Jerry Johnson, Mrs. Liz Flanagan, and Mr. Bryan Cole have made a huge impact on our lives." The brothers have competed in numerous Career Development Events and were part of the statewinning Agronomy team in 2022, finishing with a National Silver Award at the national contest in Indianapolis, Indiana.

Mitch and Mike Hopkins epitomize the FFA motto of learning, doing, earning, and serving. Their goal is to continue farming full-time and use their FFA experience to grow each year: "We want to gain more knowledge and become the best farmers we can possibly be. Agricultural life is truly the best life." These State Star Farmers and their dedicated family will continue to shine a light on the agriculture industry for many years to come.



NO LIMITS LIVESTOCK SHOW

Sarah Cate Orr of Paris FFA

For Sarah Cate Orr of the Paris FFA chapter in Henry County, working with students with disabilities has been a lifelong passion. "My aunt was the special education teacher at my elementary school," said Sarah Cate. "So, every morning I would go to her classroom before school started to hang out with her and her students. I was introduced to the special needs students at an early age, never viewing them as different from myself. My passion for working with them started very early on."

Sarah Cate's passion for showing livestock came later, at the age of 16, as one of her advisors,

Chance Young, helped her to secure a steer to show at the Henry County Fair. She fell in love with the process of showing livestock.

"One day, I decided that I wanted to put my passion of working with special needs students

and my passion of working with livestock together," explained Sarah Cate. "That is when I formed the No Limits Livestock Show. The show's purpose was to give the special needs

The No Limits exhibitors worked with their lambs all day, washing, drying, and leading, working with one or two mentors until they felt comfortable showing their lambs. Classes were divided by age, and the smiles were plentiful as the showmen were in the show ring."

Above all, Sarah Cate was thankful for the community that surrounded her as she navigated the logistics of bringing agriculture into the lives of those students. "My family and my advisors, Laura Moss, Chance Young, and Ryan Inman, were my biggest cheerleaders through every step of the process. They all had such a huge impact, and I truly couldn't have done it without them," Sarah Cate reflected.

HEART OF CHAMPIONS LIVESTOCK SHOW

Taylor Cantrell of Dyer County FFA

After lending her show goats and mentoring students at a special needs livestock show that took place in another state, Taylor Cantrell of Dyer County FFA knew that she wanted to take that joy and impact back to her hometown. "After lots of planning and support from my parents, we came up with TLC's Heart of Champions Livestock Show," said Taylor. "Initially, I wanted to do this at my home county's fair. The first year we held the show at the Dyer County Fair, it was extremely small. I had two participants when I was hoping for 20. However, after seeing the smiles on their faces, I knew it was worth it, no matter how many students showed up. This went on for two years. I knew that more students would enjoy this event, but I wasn't quite sure how to reach them."

"I was heavily involved in both 4-H and FFA at the state level throughout high school, and in those roles, traveled with the Tennessee Agriculture in the Classroom program, helping teachers incorporate agriculture into their lesson plans," she explained. "During one of these trainings, I had the opportunity to talk about my agricultural advocacy journey. The program consisted of taking my livestock and exotic animals to classrooms and daycares to give young students hands-on opportunities with these animals. On one of these occasions, Ms. Lisa Coy asked how far I would be willing to travel with my animals. After talking with her more, I found out Ms. Coy was a dedicated and passionate special education teacher in Hardin County. This was the moment when TLC's Heart of Champions Livestock Show really took off. Ms. Cov went above and beyond for her students.

Taylor continued, "By the end of summer, we had coordinated a special needs livestock show for seven different classes throughout the Hardin County School System, consisting of over 70 participants. This show became so much more than I had ever dreamed of. I had no idea how the day would go or if I was even going to have enough livestock and volunteers to pull this off." FFA chapters from Dyer and

McNairy counties came together to make the event happen. Students spent time getting acquainted with their goats, brushing them, and preparing them for the show. They then lined up and showed their goats, experiencing the satisfaction of working with livestock.

Taylor and her community of volunteers have expanded the show, and it has now been held in Dyer, Hardin, Weakley, and Lake counties, reaching over 200 special needs students. Taylor noted her gratitude for those surrounding her in this event: "I could not be more thankful for everyone who continues to help me create special experiences for these amazing students that we get to work with."

FEEL THE FIELDS AGRICULTURAL SENSORY PROJECT

Stewarts Creek FFA of Smyrna

The Stewarts Creek FFA Chapter of Smyrna, Tennessee, put their Agricultural Issues Forum Leadership Development Event research into action as they created a "Feel the Fields" agricultural sensory board with the goal of reaching special needs and neurodivergent students at their school. After months of researching the relationship between the Americans with Disabilities Act (ADA) and agriculture, the members became very passionate about all students' accessibility in agriculture. With many neurodivergent students interested in agriculture at Stewarts Creek High School, they set out to create an inclusive learning opportunity to promote mental well-being and cognitive development.

Karlee Dunn, a Stewarts Creek FFA member, said, "The comprehensive development classes (CDC) are something that have always been very important to me, as my mom is a special education teacher. Many of her students and ours at SCHS have similar disabilities. Despite this, the students at SCHS were not receiving as much accessibility, so we began brainstorming ideas for accommodations for them. We began constructing a sensory wall to bring agriculture to their classroom."

Students worked with FFA advisors Shana Boteler, Gina Stewart, and Bridget Vaughn to strategically plan the design and content of the sensory wall. The entire agriculture program voted on their favorite design and learned about different textures as stimuli for mental well-being, including plastic, sandpaper, grain seeds, fur, hide, and more. The board featured a farm named "Red Hawk Ranch" after



the school's mascot and included facts about different agricultural commodities.

They used funds from the National FFA's Living to Serve grant program to bring the project to life and volunteered more than 50 hours in building and creating it. The students presented the project to the CDC class during finals week in May of 2023 and look forward to seeing it impact students in the 2023-2024 school year and beyond. Karlee continued, "It was amazing to see how the students and teachers were so appreciative of the sensory wall and how it was going to help their students."

These FFA members and chapters have made a positive difference in their communities through passion, collaboration, and a desire to see young people of all abilities work toward the joyous rewards of agriculture.

FFA Begins Collaboration Between Department of Agriculture and Department of Education

"If you build it, they will come."

kay, technically speaking, the Kevin Costner blockbuster Field of Dreams quote is: "If you build it, he will come." But, let's not let the turn of phrase stand in the way of a good quote here.

We have all heard this pop-culture reference, and likely, many reading this publication have used the quote. The commonly held belief poignantly expressed by the quote is that with enough preparation and foresight, success is sure to follow. In fact, my FFA advisor often said, "Failing to prepare is preparing to fail."

In FFA, we subscribe to the belief that preparation is the key to success. Students prepare for every event, contest, interview, and test, which ultimately prepares them for successful careers in agriculture and beyond.

Naturally, as the Tennessee FFA Foundation and partner organizations looked to grow FFA membership and involvement, preparation for that growth was a key focus. The volunteer leaders and staff of the Foundation made building staff support for the FFA program the centerpiece goal for building membership.

The effort to build the staff support notched an important milestone in 2015 when Governor Bill Haslam and state legislators appropriated recurring funds for three new FFA staff positions in the Department of Education. The move grew staff support for agricultural education to a total of five people from just two people previously. That's down from historic support of 13 state staff people, which was drastically cut in 1980. At that time, a drop in FFA membership quickly followed, and depressed membership numbers persisted for decades.

With the addition of the staff in 2015, the FFA program grew, but it grew slowly, and turnover in the positions made sustained growth challenging.

The reality is that leading a robust program, like agricultural education, which involves three areas that each require great vision and attention, requires a robust team of professionals. Unlike any other course offered in schools, agricultural education requires students to learn in the classroom and laboratory, where they receive a grade that factors into their GPA; maintain a Supervised Agricultural Experience project outside of school; and be an active member of the FFA chapter. Teachers (or FFA advisors) are responsible for overseeing these three components all 12 months of the year.

Support for the local program is everything in an FFA chapter. Without a great FFA advisor, you simply cannot have a great FFA chapter.

So, it follows that without a great FFA state staff, you simply cannot have a great state FFA association. The proof of that claim has become indisputable in recent years. We have proven that if you build it, they will, indeed, come.

In 2021, Commissioner of Agriculture Charlie Hatcher made a clear and strong case to Governor Bill Lee about the potential of the FFA program in Tennessee. Numerous stakeholders and supporters spoke up, as well.

Recognizing the importance of the future agricultural workforce to the State of Tennessee and the value of the FFA program in the lives of students, Governor Lee recommended funding for six new staff positions in the Tennessee Department of Agriculture. A supportive state legislature agreed with the Governor's recommendation and passed recurring funds in the 2022-2023 budget for the new positions. The Tennessee Department of Education continues to house two staff people dedicated to agricultural education for a total of eight state staff members.

Since the end of the 2022 legislative session, staff have been added at the Department of Agriculture, with State FFA Director Ryan Inman leading the new team. Inman is a former Riverside FFA member and past Tennessee FFA State Officer from the 2006-2007 officer team. An important emphasis for the new positions was that each new hire had classroom experience in an agricultural education program. Inman left his role as FFA advisor

at the oldest FFA chapter in Tennessee, Paris at Henry County High School, to accept the position.

With the rollout of the Tennessee FFA
Foundation membership affiliation program,
which provides for state and national
membership dues for all students enrolled in
agricultural education, membership in the FFA
is at an all-time high. With the new and exciting
collaboration between the Departments
of Agriculture and Education to deliver a
complete agricultural education program,

students will have the best of both departments to enhance their experiences in and out of the classroom. And, with the new state staff leaders in place and great FFA advisors at home, these more than 32,000 young people have a world of opportunity ahead of them.

So, the next time you pass a corn field, channel that big-screen Kevin Costner moment and smile knowing that FFA is building momentum and our students are dreaming of a brighter future for Tennessee agriculture!
